Room Charge:

\$50 one time charge. Three hour maximum time slots. \$25 each additional hour. **Non-refundable. Payment of fee or deposit is required to confirm reservation.** Non-waivable fee covers equipment use and room maintenance. Please book Holiday parties (Christmas) 3-6 months in advance. Upon receipt of room fee/deposit/credit card number, customer agrees to all terms laid out in "conditions of use", and will take responsibility for all charges incurred.

Seating Capacity/Restrictions:

Room reservations subject to guaranteed \$250 minimum Sunday through Thursday, and on Friday and Saturday before 4pm. Party Room has limited availability on Friday and Saturday between the hours of 6-10pm. Maximum reservation is 60 people. (Minimum subject to change).

Menu Selection:

Four different Buffet Menus and several Ala-Carte selections are available for private party reservations. "Off the menu" service is not available for private parties in most cases. Bar options: cash bar (paid by guests), open bar (paid by host), Beer (kegs, bottles). Liquor service provided by main bar, through party server. No "outside alcohol" is permitted. Appetizers and Desserts are also available for an additional charge.

Pricing/Billing:

Buffet menus are "per person", (also see Ala-Carte menus), kids 6 years and under are free, kids 7 to 12 years are \$7.95. Final payment is due at the conclusion of the event, prior to leaving premise. **Only one check will be presented.** Any unpaid bar tabs will be the responsibility of the host. Prices and options subject to change without notification. **Gratuity and Room Charge not included. Guaranteed minimum enforced. Tax and 20% gratuity will be added to final bill.**
